- a) Engagement of the Refractionist will be only for one year purely temporary on contractual basis. His engagement can be extended upto the age of 60 year, keeping in view of his/her satisfactory working report every year.
- b) His/her duty is to carry out Refraction of the patients and to assist other patients in OPD/OT in Northern Railway, Central Hospital, New Delhi.
- c) During the duty hours, he/she will not attend any private patient and does not leave the Hospital premises without the permission of the competent authority.
- d) He/she will be required to work in Northern Railway, Central Hospital, New Delhi. 07 hours a day from 09.00 hrs to 16.00 hrs i.e. from Monday to Saturday on all working days.
- e) The engaged Refractionist be paid a consolidated honorarium of Rs. 14,950/- p.m. (Fourteen Thousand Nine Hundred Fifty Only) without any allowances from Divisional Staff Benefit Fund.
- f) Casual Leave of 08 (Eight) days shall be permissible to the engaged Refactionist and no other kind of leave shall be admissible
- g) The selection for the post if Refractionist in Central Hospital, New Delhi will be held on the basis of Viva Voice.

- h) Deduction on pro-rata basis shall be made from the consolidated monthly honorarium for absence not covered by Casual Leave.
- i) No TA/DA shall be admissible to the engaged Refractionist and no expenses to join the new assignment shall be permissible. Candidates shall have to make their own arrangement for stay during the selection, if required.
- No Railway Quarters shall be provided by the Railway Administration to the engaged Refractionist during the period of engagement.
- k) He/She will not be treated as Railway employee and does not entitle for any privilege, admissible to a Railway employee, No medical treatment from the Railway Hospital is admissible to the Refractionist or his/her family members.
- No Railway Passes/PTOs shall be permissible in favour of the engaged Refractionist.
- m) The engaged Refractionist shall not be allowed to issue any sick and fit certificate in favour of the Railway employees. Private practice shall be permitted but without hampering the normal duty in the Railways.
- n) Services of engaged Refractionist shall be terminated on reaching the age of 60 years or after the completion of period of engagement, whichever is earlier. Even prior to these, the services can be terminated on 14 days notice on either side. The Divisional Staff Benefit Fund (DSBF) Committee/HQ division shall not be bound to assign any reason for such termination and this power may be exercised by the Chairman/DSBF Committee/HQ division and the Refractionist will have no right to challenge the order of DSBF committee to this effect in any court of law.
