Subject: Withdrawal of three (03) posts of Assistant Town Planner of Town Planning Organization, J&K


Notification No. **07**-PSC (DR-P) of 2021
Dated **08**-07-2021

Whereas, the Housing & Urban Development Department vide their letter No. HUD/Architect/16/2015 dated 12-07-2017 referred 03 posts of Assistant Town Planner (State Cadre) in Town Planning Organization, J&K to the Public Service Commission for selection of suitable candidates; and

Whereas, the said posts were advertised vide Notification No. 08-PSC (DR-P) of 2017 dated 18.09.2017; and

Whereas, the Housing & Urban Development Department vide letter No. HUD/Arch/02/2020 (C-7186) dated 18-05-2021 intimated that owing to the enforcement of the Reorganization Act, 2019 in the UT of J&K and proposed revision of the J&K Town Planning Organization Recruitment Rules, 2021 being undertaken by Housing & Urban Development Department, the department sought advice of the Department of Law, Justice and Parliamentary Affairs in the matter. Based on the advice of the Department of Law, Justice & Parliamentary Affairs Department and the approval of Competent Authority, the three (03) posts of Assistant Town Planner referred to PSC vide letter No. HUD/Arch/16/2015 dated 12-07-2017 may be treated as withdrawn.

Now, therefore, the Notification No. 08-PSC (DR-P) of 2017 dated 18-09-2017 issued under endorsement No. PSC/DR/Asstt-Town Planner /14/2017 dated 18-09-2017 is hereby withdrawn ab-initio.
