Whereas, the interview for (01) post of Lecturer Prosthodontics (GDC-Srinagar) in Health & Medical Education Department, advertised vide Notification No. 06-PSC (DR-P) 2019 dated 22.04.2019, was conducted on 15.07.2021 at J&K Public Service Commission office Srinagar; **and**

Whereas, during the course of interview, the Board observed that one of the candidates submitted index of Special Attributes like Research Papers and Original Articles wherein, one of the experts on the panel of interview board was shown as the third author of one of the publication submitted by the candidate at the time of interview; **and**

Whereas, a representation was also received from other aspiring candidates seeking conduct of fresh interview in the said discipline on the same grounds as were noticed by the interview Board; **and**
