**Subject:- Cancellation of selection of the candidate for the post of "Jr.Staff Nurse" (Health and Medical Education Department) vide advertisement Notification No. 03 of 2014 Dated 30-12-2014 under item No.289 Divisional Cadre Jammu.**

1) Whereas, the J&K Services Selection Board issued the selection list of the candidates for the post of **"Jr.Staff Nurse" (Health and Medical Education Department) vide advertisement Notification No. 03 of 2014 Dated 30-12-2014 under item No.289 Divisional Cadre Jammu** and recommended the same to the intending department vide this Office letter No. SSB/Secy/Sel/2016/20287-93 dated 18-11-2016 for further course of action; and

2) Whereas, the selection of the candidate namely **Paramjit Kour W/O Navjot Singh R/O Dabkhar RS Pura Jammu, figuring at S.No. 03/OSC** was kept withheld subject to production of pre-marital certificate and bonafide certificate of Diploma thereof; and


3) Whereas, the candidate has submitted the Bonafide certificate of G.N.M issued by the Punjab Medical Institute Campus, Near Gol. Market Jalandhar Punjab vide No. Date Nil. Date of admission 20-01-2006, completed under Study Centre. Further, the Board has written a letter to the Registrar, J&K State Para Medical Council, Jammu vide No.SSB/Sel/Verif/2017/3505 Dated 23-03-2017 regarding verification/clarification of particulars of certificate. In response of this office letter a reference has been received from the concerned vide No.JKPMC-19-20/63/6240 Dated 30-04-2021 , which reveal that J&K Paramedical Council as per its present policy cannot register the diploma certificate of GNM course issued in favour of the above said candidate as the concerned Institute/University is not recognized by any Registered Council/Indian Nursing Council/State Government of University Grant Commission and ;

4) Whereas, the case of the candidate was placed before the Board in its 186th Board Meeting and Board decided to declare the candidate Not Eligible on the basis of clarification received from the Registrar, J&K State Para Medical Council, Jammu.

Now, therefore, in view of the above position, the withheld selection of **Paramjit Kour W/O Navjot Singh R/O Dabkhar RS Pura Jammu, figuring at S.No. 03/OSC** for the post of "Jr.Staff Nurse" (Health and Medical Education Department) vide advertisement Notification No. 03 of 2014 Dated 30-12-2014 under item No.289 Divisional Cadre Jammu is hereby **cancelled abinitio** and indenting Department is requested to operate the waiting list under OSC Category, if required.
