**Subject: - Selection List of candidates under SRO 202 for the post of Fisheries Development Assistant in Animal and Sheep Husbandry Department, Item No. 016 (03 of 2017) Divisional Cadre Kashmir.**

**Whereas,** the J&K Services Selection Board vide Notification No. 03 of 2017 dated 12.11.2017 under Item No. 016 notified the posts of Fisheries Development Assistant in Animal Sheep Husbandry Department Divisional Cadre Kashmir with the breakup of posts as follows (Total=06, OM-03, RBA-01, SC-01 and ST-01); and

**Whereas,** the qualification prescribed by the Department for the above said post is "Graduate in Fisheries Science (B.F.Sc.) or B.Sc. with Zoology or Industrial Fish and Fisheries from any recognized University"; and

**Whereas,** you applied for the said post under ST category; and

**Whereas,** a written Examination was held on the 18<sup>th</sup> April to 15<sup>th</sup> April, 2018; and

**Whereas,** the Counselling/Document Verification for the above said post was held on 18<sup>th</sup> July, 2018, in which three (03) candidates under ST category appeared for the document verification; and

**Whereas,** the Services Selection Board vide letter No. SSB/Secy/Sel/2019/306-12 dated 09.01.2019 forwarded the selection list of the above said post to the Indenting Department with the remarks in the Selection List in respect of ST category "as selection of one post deferred in view of pending claims ; and

**Whereas,** one Shahziya Shah D/o Mubarak Shah R/o Printee Panikhar Kargil approached the Hon'ble Central Administrative Tribunal Jammu Bench vide T.A No. 5131/2020 and Diary No, 7940/2020 and prayed for her selection against the post of Fisheries Development Assistant (FDA) in terms of Advertisement Notification and to extend all other benefits; and



**Whereas,** the Central Administrative Tribunal off the case and passed the order dated 15.04.2021, the operative Part of which is as follows: -

*"In the counter affidavit filed by the official respondent, it is stated that the 4<sup>th</sup> respondent laid her claim and that she scored 42.71 marks. It should not have been difficult for the official respondents to select a candidate against the post reserved in favour of STs. The candidates with necessary certificate about social status and the marks scored by them are before them. In case, any claim is made, the same needs to be decided duly passing an order, furnishing the reasons. There cannot be any justification to keep the matter pending, particularly when all other posts are filled up.*

*We, therefore, dispose of this TA, directing the appointing authority to finalize the selection and appointment to the post of FDA reserved in favour of ST, referable to the advertisement dated 17.11.2017, within a period of four weeks from the date of receipt of a copy of this order, strictly in accordance with the merit among the ST candidates, whose social status is beyond any pale of doubt".*

Therefore, in view of the order passed by the Hon'ble Central Administrative Tribunal dated 15.04.2021, you are hereby directed to appear the Secretary, Services Selection Board within 15 days alongwith the all requisite documents i.e. Date of Birth Certificate, Eligibility Certificates, Category certificate and other relevant document, in support of your claim so that the Board is in a position to finalize the selection list for the post of FDA (Fisheries Development Assistant) under ST category.
