## Notice Dated: 16-11-2021

Whereas, the J&K Public Service Commission, vide Notification No.13-PSC (DR-P) of 2019 dated 09.10.2019, invited online/offline applications on prescribed format from the permanent residents of Jammu & Kashmir possessing the prescribed qualification for the 08 posts (OM=05 & RBA=03) of Librarian in the Higher Education Department under 1st Special drive and in response to the said Notification, the Commission received 125 application forms; and

Whereas, on verification/scrutiny of the application forms, some candidates were found deficient of requisite documents and accordingly the Deficiency Notice was issued vide the Commission's Notice dated **02.09.2021** with the advise to get the deficient documents submitted within 10 days from the issuance of Deficiency Notice, failing which, it shall be presumed that the candidate is not in possession of the said documents and further shortlisting of candidates shall be taken up without consideration of the said deficient documents of these candidates. It was further notified that no claim, of whatsoever kind, shall be entertained after stipulated time period; and

Whereas, the deficient documents were received from some of the candidates in response to notice dated 02.09.2021 with in the stipulated time period and the said documents were again verified/scrutinized for provisional short-listing of the candidates for interview; and

Whereas, the provisional short-listing of the candidates was conducted as per the relevant provisions of Rule 51 of the J&K Public Service Commission (Business and Procedure) Rules, 1980, as amended from time to time, which provides for weightage to be given to the Academic performance, constituting total 50 points (On pro-rata basis), with the break-up tabulated as under: -

Whereas, the rule 51 of the J&K Public Service Commission (Business and Procedure) Rules, 1980, as amended from time to time, further provides for the short-listing of provisionally eligible candidates to be called for interview in the ratio of 1:3 and, as such, total 15 candidates under Open Merit Category for 05 advertised posts & 09 candidates under RBA Category for 03 advertised posts respectively are to be provisionally shortlisted for interview on the basis of the Academic Performance in light of the record submitted by the candidates as per the weightage details elaborated above; and

Whereas, after compilation of the data with respect to the above weightage points in light of the record/documents submitted by the candidates and the prescribed ratio to be adopted for short listing of provisionally eligible candidates for interview, the cut off merit under OM Category is notified as **31.90**&that of RBA Category as **26.19**.
