Consequent upon the indent/requisition received from the Health & Medical Education Department vide No. ME/NG/53/2018-PF dated 10.01.2019 for 08 posts of "Technical Assistant /Technician", (Health and Medical Education Department (GMC Baramulla), Divisional Cadre Kashmir, the advertisement notification in respect of said posts was issued by the Board vide Notification No. 02 of 2019 under Item No. 014, with below mentioned category wise break up: -

Pursuant to aforementioned advertisement notification, the Jammu and Kashmir Services Selection Board (JKSSB) conducted Computer Based Test (CBT) for the above said post on 11<sup>th</sup> of May 2019. On the basis of performance of the candidates in the Computer Based Test, provisional selection list was issued by the Board vide Notification No. SSB/Secy/Sel/2019/5160-66 dated 05.10.2019 and 33 candidates were called for document verification/counselling on 2<sup>nd</sup> and 4<sup>th</sup> of November, 2019. The selection process to the post of Technical Assistant/Technician (Anesthesia) has been subject matter of SWP No. 605/2019 titled "Tajamul Ahmad Dar V/s State of J&K and other" in the Hon'ble High Court of J&K at Srinagar and the case was transferred to Hon'ble Central Administrative Tribunal (CAT)

in the month of September, 2020 in TA No. 062/1476/2020 along with MA 62/1413/2020. The Hon'ble CAT vide its order dated 08.10.2020 passed the order, the operative part of which is reproduced as below:

# "...Accordingly, the MA is dismissed as withdrawn and TA is also dismissed. No costs"; and

The key issue whether the candidates who possess higher qualification than the prescribed in the rules are eligible for the post of Technical Assistant/Technician (Anesthesia), Radiographic Technician, Clinical Staff for Casualty Bed and Theatre Assistant was also under adjudication separately in the TA No. 62/7196/2020 titled Ajaz Ahmad Ahanger V/s UT of J&K and others and the Central Administrative Tribunal vide its order dated 25.10.2021 also dismissed the TA 62/7196/2020 and passed the following order:

## "...We do not find any merit in the TA, which is accordingly dismissed. There shall be no order as to costs"

The above said judgment of the Hon'ble Central Administrative Tribunal was challenged in the Hon'ble High Court of Jammu & Kashmir and Ladakh at Srinagar in WP (C) No. 2251/2021 titled Ajaz Ahmad Ahanger and other V/s UT of J&K and others. In the above said writ petition the Hon'ble High Court vide dated 16.11.2021 passed the following order:

"...For the foregoing reasons, we do not find any error or illegality in the impugned judgment passed by the Tribunal. The impugned judgment of the Tribunal is well reasoned and lucid. The same does not call for any interference. The writ petition lacks merit and the same is, accordingly, dismissed".

Considering all the facts and circumstances of the case together with the aforesaid orders of the Hon'ble Courts, the selection list along with waiting list for the post of Technical Assistant/Technician (Anesthesia) was prepared and placed before the Board in its 192<sup>nd</sup> Board meeting held on 21.11.2021. The Board after taking into consideration all the facts before it, decided to approve the selection list prepared by the concerned Section of the Board. Accordingly the selection list along with waiting list for the aforesaid post of Technical Assistant/Technician (Anesthesia) was notified

You are further requested that in case any certificate/document, during the course of verification, turns out to be fake/fictitious, the Board may kindly be kept posted and appropriate criminal proceeding against such candidates may please be initiated.
