Whereas, Higher Education Department vide letter No.HE-Coll/Coord /Apptt/AP/2017 dated 18.10.2017 referred 10 posts (OM: 06, RBA: 02, ST: 01 & ALC: 01) of Assistant Professor Home Science for selection of suitable candidates; **and**

Whereas, the Jammu & Kashmir Public Service Commission advertised these posts vide Notification No.10-PSC(DR-P) of 2017 dated 27.10.2017 and received 71 applications, which were scrutinized and 23 eligible candidates were called for interview which was conducted on 20.09.2021 with the assistance of Experts from outside UT; **and**

Whereas, on the basis of the performance in the interview in pursuance of Rule 51 of the J&K Public Service Commission (Business & Procedure) Rules, 1980, the Commission in its meeting held on 03.11.2021 approved the provisional select list for the posts of Assistant Professor, Home Science; **and**

Whereas, the provisional list was issued vide Notification No.92-PSC(DR-S) of 2021 dated 07.12.2021 wherein 8 candidates were selected provisionally under different categories with the stipulation that objections, if any, be submitted to the Commission within five days from the issuance of the provisional select list for examination/disposal and that no claim, whatsoever, shall be entertained after five days from the date of issuance of Notification; **and**

Whereas, in response to the above, 02 representations have been received in the Commission as per the details below and are, accordingly, disposed of with the clarification/remarks indicated against each:-

01	Anesa Majeed	<p>The candidate has submitted the following grievances:-</p> <ol style="list-style-type: none">1. That no any point has been given against her 01 UGC paper publications, but at the time of interview one Hon'ble Member and Panelists of PSC has entertained the paper and final point sheet was signed by her.2. Further, she has also stated that she was feeling aggrieved by the points of interview + Demo, but her interview went very excellent and the Panelists were very satisfied with her performance. So, she has requested to kindly recheck her interview points in the sheets provided to the panalists at the time of interview.	<ol style="list-style-type: none">1. The candidate has submitted one UGC Publication before the interview board which has not been accepted by the experts being review based paper.2. The points are awarded in the interview on the basis of the performance of the candidate(s) and assessment of the experts.

02	Iesha Sharma	The candidate has stated that one of her publication was in old UGC Carelist, so, she bag 0.25 instead of .50 as per the criteria. The candidate has also stated that two posts of RBA and ALC are still lying vacant and she aspire for one of them being number one in open merit waiting category, so she has requested to consider these vacant posts in open merit, so as to give opportunity to the aspirants who was not selected as per merit list.	The Assessment of Special Attributes including Publications is the exclusive domain of experts on the interview board. As regards conversion of posts reserved for ALC & RBA category candidates into OM seats, the same is not permissible as per rules.
