Subject: Select List for the posts of Assistant Professor (Bio-Resources) in Higher Education Department- Disposal of representation thereof.

Whereas, the Higher Education Department vide letter Coll/Coord/Apptt/AP/2017 dated 18.10.2017 referred 10 posts [OM: 05, RBA: 02, SC:01, ST: 01 & ALC:01] of Assistant Professor in the discipline of Bio-Resources for selection of suitable candidates; and

Whereas, the posts were advertised vide Notification No.10-PSC(DR-P) of 2017 dated 27.10.2017 and 88 applications were received. Upon scrutiny of the documents of the candidates, 03 eligible candidates were called for interview which was conducted on 17.09.2021 with the assistance of Experts from outside UT; and

Whereas, the provisional select list was issued vide Notification No.91-PSC(DR-S) of 2021, dated 07.12.2021 wherein 03 candidates were selected provisionally under OM Category, with the stipulation that objections, if any, be submitted to the Commission within five days from the issuance of the provisional select list for examination/disposal and that no claim, whatsoever, shall be entertained after five days from the date of issuance of Notification; and

In response to the above Notification, 01 representation has been received in the Commission as per the details below and is, accordingly, disposed off with the clarification/remarks as indicated:-

S.No	Name of the Candidate	Claim(s)	Remarks
01	Monica Sangral	The candidate has stated that she has been shortlisted for the post of AP-Bio-Resources and she appeared in the interview on 17.09.2021 as per the Hon'ble High Court order dated 20.09.2019. Further, she has stated that Vide selection Notification 91-PSC(DR-S) of 2021, dated 07-12-2021, wherein the selection list was notified but her result was not declared by the PSC. So, she has requested to declare her final result pertaining to post of AP-Bio-Resources.	The candidate was allowed to appear in the interview on the Court direction, which is reproduced below:- "...allow the petitioner to participate in the selection process of the post of Assistant Professor under SC category advertised vide Notification No.10-PSC(DR-P) of 2017 dated 27.10.2019 (should be 27.10.2017) at his own risk and responsibility. However, the result of the petitioner shall not be declared till further orders of the Court. Mere participation of the petitioner in the selection process shall not confer any right or title on him for his consideration."
