Whereas, the Home Department vide indent No. Home /PB-III/ 34 /2021 dated 02.07.2021 requisitioned/referred, 800 posts of Sub-Inspector;

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) vide Advertisement Notification No. 06 of 2021 dated 21.10.2021, invited online applications from eligible candidates for participating in the selection process for aforesaid 800 Posts of Sub-Inspectors; and

Whereas, the requirement of age for Open Merit & various Reserved Categories candidates as notified in the aforesaid Advertisement Notification in terms of rule 176(1) (c) of S.O 214, dated 01-07-2021 and S.O 361 dated 20-10 -2021 is as under:

"A candidate must have attained age of 18 years but not crossed the age of 28 years on 1st January of the year in which notification inviting applications is issued by the Jammu and Kashmir Services Selection Board", and;

Whereas, the Home Department vide letter dated 23.11.2021 conveyed to increase the number of posts of Sub-Inspectors by 400, viz, from 800 to 1200, and subsequently, vide Notification No. SSB/Secy/2021/7926-42 dated 24.11.2021 JKSSB increased the number of posts from 800 to 1200, and;

Whereas, the date of commencement for submission of online applications was 10-11-2021 and the last Date for submission of online applications was fixed as 10-12-2021; and

Whereas, the last date for submission of online applications for aforesaid posts advertised vide Advertisement Notification No. 06 of 2021 dated 21.10.2021 was



extended upto 18-12-2021 vide Notice No. SSB/Secy/2021/8547-64 dated 08.12.2021 and further upto 26-12-2021 vide Notifice No. SSB/Secy/2021/9008-24 Dated 23-12-2021; and,

Whereas, the Home Department vide S.O notification No.420 dated 10-12-2021 has prescribed upper age limit for Open Merit & various Reserved Categories candidates as 30 years and 32 years in respect of the in-service Police Personnel, as on 1st January,2021.

Whereas, the Jammu and Kashmir Services Selection Board vide No. SSB/Secy/2021/8628-44 dated:-10-12-2021 issued corrigendum to the Advertisement Notification wherein Maximum Age Limit for Open Merit & various Reserved Categories candidates has been prescribed as 30 years and 32 years in respect of the in-service Police Personnel, as on 1st January,2021.

Whereas, 37 candidates approached the Hon'ble Central Administrative Tribunal through the medium of OA No. 1855/2021 with M.A. 1973/2021 titled Vikram Kumar & others v/s Union Territory of J&K & others and the Hon'ble Central Administrative Tribunal vide order dated 17/12/2021 directed that the application forms of the applicants be accepted provided the last date is sustaining. The Board, in compliance with the same directions of the Hon'ble Tribunal, issued notice vide No.SSB/Secy/2021/8863-78 dated:-18-12-2021 for allowing the said applicants to submit their offline applications forms by or before 31 December 2021.

Whereas, 325 candidates approached the Hon'ble Central Administrative Tribunal Bench Jammu by way of 11 different OA's cases before Jammu Bench and 239 applicants approached Hon'ble Central Administrative Tribunal Bench Srinagar by way of 07 different OA's before Srinagar Bench claiming therein same relief as provided in OA No. 1855/2021 titled Vikram Kumar and Others Vs UT of J&K and the Hon'ble Tribunal vide various orders passed in aforementioned OAs, directed the respondents to accept the application forms of the applicants arranged therin.
