Whereas, vide Notification No. 14-PSC (DR-P) of 2021 dated:18.12.2021 online applications were invited from Domiciles of the UT of Jammu & Kashmir for filling up the posts of Medical Officer (Allopathic) in Health & Medical Education Department, in accordance with the Recruitment Rules issued vide SRO 325 dated 12.07.2013, read with SRO 388 dated: 10.09.2018, J&K Probationer (Conduct of Service, Pay and Allowance) And Fixation of Tenure Rules, 2020, notified vide SO 192 of 2020 dated: 17.06.2020 and J&K Public Service Commission (Business and Procedure) Rules, 2021.

2. Whereas, in response to the said notification, 2505 online applications were received; and

3. Whereas, upon scrutiny of the online application forms, it has been observed that some applicants have wrongly mentioned validation date of Category certificate /MCI Registration date, in their online application forms. Besides, one candidate has not uploaded his Domicile Certificate.

4. Now, therefore it is hereby informed that:-

i. the candidates whose names are indicated in **Annexure "A"** to this notice are hereby directed to submit the proof of having valid RBA Category Certificate/ MCI Registration Certificate issued well within the cutoff date i.e. 19.01.2022. The documents must be submitted **by or before 12.05.2022 at J&K Public Service Commission, Solina, Srinagar/Resham Ghar Colony, Bakshi Nagar, Jammu**, failing which their candidature shall be rejected without any further notice.

ii. the candidature of the candidates whose names are indicated in **Annexure "B"** to this notice is hereby rejected for the reason/(s) shown against each. However, if any candidate feels aggrieved of the rejection of his/her candidature, he/she may file an appeal before the Appellate Authority of the Commission with valid supporting documents against his/her rejection within a period of six days from issuance of this notice (i.e. **by or before 12.05.2022**), **at J&K Public Service Commission, Solina,**

Srinagar/Resham Ghar Colony, Bakshi Nagar, Jammu. No claim, whatsoever, shall be entertained after the stipulated period.

- ☞ The candidature of all the candidates appearing in the Written Examination scheduled to be held on **24.05.2022**, shall be purely provisional.
- ☞ Claiming eligibility by misrepresentation, concealment of any material fact(s) or impersonation or fraud, shall tantamount to cancellation of his/her candidature followed by disciplinary action by the Commission.
- ☞ The Commission reserves the right to cancel the candidature of any candidate found ineligible at any stage of Selection Process at which such ineligibility shall be detected.


