Whereas, the Health & Medical Education Department vide letter No. ME/GAZ-53/2020 dated 28.09.2020 and No. ME/GAZ-187/2014 dated: 11.08.2021, referred 03 posts of Lecturer in the discipline of Ophthalmology in GMC-Jammu and GMC-Srinagar, for selection of suitable candidates as per the following breakup:-

Whereas, the J&K Public Service Commission vide Notification No. 12-PSC (DR-P) of 2021 dated 14.12.2021, advertised the said posts for selection of suitable candidates; and,

Whereas, the Commission received 38 applications [GMC-Jammu:14, GMC: Srinagar:24], which were scrutinized and 34 eligible candidates [GMC-Jammu:13, GMC: Srinagar:21] were called for interview. Out of 34 candidates, 04 candidates applied both for GMC Jammu and GMC Srinagar; and,

Whereas, the interview of the candidates was conducted on 24.05.2022 & 25.05.2022 with the assistance of experts; and,

Whereas, 02 more candidates were called for interview on the basis of the directions from Hon'ble Court. The operative part of the directions are reproduced as under:-

O.A./297/2022 (Srinagar) TITLED ARSHI NAZIR SHIKARI & OTHERS V/S PSC

"...In the meantime, respondents are directed to allow the applicants to appear in the interview at their own risk and cost."

O.A./502/2022 TITLED SAKSHI SAHNI V/S H&ME

"..Allow the applicant to participate in the interview from the post in question on her own risk and responsibility, however,

the result of the applicant shall not be declared till further orders from the Tribunal."

Now, therefore, on the basis of the performance in the interview in pursuance of Rule 44 of the J&K Public Service Commission (Business & Procedure) Rules, 2021 as amended from time to time and other related parameters, the merit of the candidates who have appeared in the interview is enclosed as **Annexure-"A"** to this Notification.

Consequent upon the above, the provisional **select list** of the candidates against the available posts is given in **Annexure-B** to this Notification.


