Subject: Select list for the post of Lecturer Anaesthesiology in GMC Srinagar in Health & Medical Education Department-Disposal of representation thereof.

Whereas, the Health & Medical Education Department vide letter No. ME/GAZ-53/2020 dated 28.09.2020 and No. ME/GAZ-187/2014 dated 11.08.2021, referred 10 posts of Lecturer in the discipline of Anaesthesiology in GMC-Jammu/ Srinagar, for selection of suitable candidates; and,

Whereas, the interview of eligible candidates was conducted w.e.f. 18.04.2022 to 20.04.2022; and,

Whereas, the provisional select list for the post of Lecturer Anesthesiology was notified vide Notification No. 06-PSC (DR-S) of 2022 dated 26.04.2022 subject to objection, if any, within five days for examination and disposal; and,

Whereas, in response to the Notice, a representation was received from Dr. Imran Hussain Bhat, who figures in the select list in GMC Srinagar, under OM Category, with merit of 77.95 points, with the following submissions made therein:-

- I. His higher qualification (DM Cardiac Anesthesia) has been taken as 3 years' experience rather than counting in qualification segment.
- II. He has 10 months teaching experience in addition to requirement for post for which he should have been allotted 0.75 point in experience segment, which has not been granted.
- III. The expert panel accepted one of his paper presentations, for which no additional points have been granted, as he has submitted two case series which are equivalent to original papers, and have not been granted any points for the same.

Whereas, the representation was examined with reference to records which revealed that the higher qualification (DM Cardiac Anesthesia) of the doctor has not been treated as equivalent to DM Anesthesia as being only a branch of Anesthesia. However, DM Degree in Cardiac Anesthesia was counted towards experience, thus his total experience was three years, 10 , Months for which maximum available points i.e three points, have been awarded. Further, the doctor had one certificate related to award of Scholarship which has been accepted under "Conferences" for accord of weightage, which is not prescribed under rules, therefore, no weightage has been granted. Further, the case series presented by the applicant has not been given weightage as the same is not prescribed under the norms/rules.

The representation is, accordingly, disposed-off.
