Whereas, the J&K Public Service Commission, vide Notification No.09-PSC (DR-P) of 2021 dated 03.09.2021, invited online applications from the applicants who are domiciled in the Union Territory of Jammu and Kashmir, for 05 posts (OM=03, RBA=01, SC=01) of Assistant Professor, **Islamic Studies**. In response, the Commission received 101 application forms (OM=84, RBA=16, SC=01); and,

Whereas, Rule 45(i) of J&K Public Service Commission (Business and Procedure) Rules, 2021, as amended from time to time, provides that weightage to be given to the academic performance (to be worked out on prorata basis) for the post of Assistant Professor and its equivalent in Higher Education Department is as under:-

Whereas, Rules 45 of J&K Public Service Commission (Business and Procedure) Rules, 2021, as amended from time to time, further provides for shortlisting of the eligible candidates to be called for interview in the ratio of 1:3. As such, 09 candidates under OM category, 03 candidates under RBA category and 03 candidates under SC category are to be shortlisted for interview on the basis of academic performance as recorded in the documents submitted by the candidates; and,

Whereas, after compilation of the data with respect to the above given weightage points and the ratio to be adopted for short-listing of candidates for interviews only, the cut off merit under OM and RBA category is **46.09 and 45.39 respectively**. Due to ineligibility of the only SC candidate, the cut-off merit could not be drawn.


