## **NOTIFICATION NO. 69-BOPEE OF 2022**

**DATED: 20-10-2022**

In terms of Notification No. 055-BOPEE of 2022 dated 09-09-2022, a Tentative Merit List of 1623 eligible candidates for admission to various Disciplines in CET (B.E./B.Tech.) Courses-2022 in the Government/Private Institutions of the Union Territory of J&K was issued, apart from notifying the list of 291 candidates, who had not uploaded/ submitted their marks cards and made available on the official website of the Board [www.jkbopee.gov.in](http://www.jkbopee.gov.in) for inviting objections, if any, from the eligible candidates upto 13th of September, 2022. The Board received only one objection from a candidate which was duly considered and decided. Further, 18 candidates submitted their deficient documents viz. marks card etc.

2. An Updated Rank Wise Merit List, forming Annexure "A" to this Notification for CET-Engineering courses 2022 has accordingly been prepared, on the basis of the merit of the candidates and is hereby notified for information of all the eligible candidates who have applied for admission to CET-Engineering Courses 2022. The Board shall simultaneously conduct their Physical Round of Counselling at BOPEE Office Jammu / Srinagar through Video Conferencing for allotment of seats as per the following schedule:

### **NOTE:**

1. Keeping in view time constraint, all candidates who are willing to participate in counselling are directed to bring along the following original documents for on spot completion of admission formalities, on provisional basis:
  - a) 12th Class Marks Card.
  - b) Domicile Certificate of UT of J&K / Ladakh.
  - c) Category Certificate, including TFW, if any.
  - d) Date of Birth Certificate (Issued by J&K Board of School Education / Centre Board/other Boards)
2. The Board has not included the names of those candidates in this updated Merit List (ML) who have failed to submit their deficient documents i.e. 12th marks Card or any other deficient certificate upto the last date fixed by Board i.e. 13-09-2022.
3. Candidates shall have to physically report to the BOPEE offices Jammu/Srinagar for registration/attendance & fulfillment of other formalities between 08:00 A.M. to 10:30 A.M. on the allotted day /date of their counselling.
4. The allotment of seats (discipline/institution) shall be made in pursuance of S.O. 127 dated 20-04-2020 and as per S.O. 249 dated 23-07-2021 to the eligible candidates in the Merit List.
5. A candidate who may miss his/her counselling allotted day/date may be allowed by the Board to participate in the counselling on the next day, provided that he/she does not stake any claim on a seat which may have already been allotted to a candidate next in order of merit (to such candidate) on the ground that the candidate could not participate in the physical round of counselling earlier when the seat was available.
6. The candidates who fail to join the allotted college after completion of counselling shall not be eligible/allowed to participate in the subsequent round of counselling i.e. up gradation rounds.
7. Seat matrix shall be uploaded separately in due course of time before counselling.
8. The candidates must remain in touch with the Board and visit the official web site [www.jkbopee.gov.in](http://www.jkbopee.gov.in) for any updates about the Counselling Process and Daily Based Seat Matrix.
9. Any candidate who may not be able to attend counselling physically owing to a valid reason can authorize a person (through Authority Letter-on prescribed format) from his/her family member to participate in the counselling on his/her behalf at BOPEE offices Jammu/Srinagar on the allotted day/date of counselling as per his/her Rank.
10. The heads of the institutions are requested to depute their authorized representative(s) at BOPEE office Jammu/ Srinagar during the days of counselling along with copy of approved fee structure order of the Govt. In connection with completion of on the spot admissions of the candidates. They shall furnish the shortfall of candidates, if any, on 25.10.2022 upto 1.00 pm.
11. The Board reserves the right to notify such changes as may become necessary in view of any technical difficulty or the reasons beyond its control. Further, the Board shall not fill CDP Category seats during first round of counselling as the matter is subjudice in the Hon'ble High Court of J&K and Ladakh and shall be reserved for candidates belonging to that category.

The other terms and conditions shall remain the same as notified in the Information Brochure and Notifications/ Notices issued by the Board in this regard from time to time.
