Desirable experience/skills :

1. The Independent Consultant should be IT Governance expert or IT Project Manager, with knowledge and experience of:
 - a. Implementation of Enterprise class portals/systems preferably in a e-governance setup.
 - b. Bid process management.
 - c. Information/ cyber security management.
 - d. IT/ data security management.
 - e. SLA, contract and vendor management.
2. Any good IT Governance certification (PMP, ITIL, CISM, CISA, etc.) would be preferred.
3. He/she should have knowledge of data privacy and international laws/ standards/ frameworks related to IT.
4. He/she should have managed teams preferably in the government sector, should be good in coordination, interpersonal skills and writing reports and should have excellent MS Office and data analysis skills.
