
Whereas, the J&K Public Service Commission, vide Notification No. 06-PSC(DR-P) of 2021 dated 07.07.2021, invited online applications, on the prescribed format, from the Domiciles of Jammu & Kashmir (UT) possessing the prescribed qualification for one (1) post, under OM Category, of Scientific Officer, Biology/Serology FSL, in Home Department; **and,**

Whereas, the written examination was conducted w.e.f 14.11.2022 to 18.11.2022, and the result was declared vide Notification No. PSC/Exam/2022/38 dated 19.12.2022, in which 05 candidates were declared to have qualified for Interview/Viva Voce; **and,**

Whereas, it was clearly stipulated in the result notification that eligible candidates only, possessing the requisite qualification, shall be allowed to appear in the Oral Test/Viva-Voce; **and,**

Whereas, after scrutiny of the application forms of the candidates, it has been found that one candidate, namely, Rafiq Ahmad Rather bearing **Roll No. 8000036** does not possess the relevant qualification for the post of Scientific Officer, Biology/Serology, therefore, is ineligible for the post.

Now, therefore, in view of the above, the candidature of the above candidate is hereby rejected for the post of Scientific Officer, Biology/Serology, FSL, in Home Department, notified vide Notification No. 06-PSC(DR-P) of 2021 dated 07.07.2021. If the candidate feels aggrieved with the rejection of his candidature, he may file an appeal before the Commission within 10 days from the date of issuance of this Notice. No claim, whatsoever, shall be entertained after the stipulated period.
