Whereas, the J&K Public Service Commission, vide Notification No. 06-PSC(DR-P) of 2021 dated 07.07.2021 invited online applications, on the prescribed format, from the Domicile of Jammu & Kashmir (UT) possessing the prescribed qualification for two (2) posts, one each under OM and RBA Category, of Scientific Officer, Chemistry & Toxicology, FSL, in Home Department; **and,**


Whereas, the written examination was conducted w.e.f 14.11.2022 to 18.11.2022, and the result was declared vide Notification No. PSC/Exam/2022/38 dated 19.12.2022, in which 12 candidates were declared to have qualified for Interview/Viva Voce; **and,**

Whereas, it was clearly stipulated in the result notification that eligible candidates only, possessing the requisite qualification, shall be allowed to appear in the oral test/viva-voce; **and,**

Whereas, after scrutiny of the application forms of the candidates, 02 candidate with following roll numbers have been found ineligible for the post of Scientific Officer, Chemistry & Toxicology FSL in Home Department for the reasons shown against each:-
