On the basis of the results of the J&K Prosecuting Officer (Main) Examination, 2022, held by the J&K Public Service Commission from 31.05.2023 to 17.06.2023, the candidates with Roll Numbers as per **Annexure-A** to this notification have qualified for Personality Test for selection to the post of J&K Prosecuting Officer (G) in Home Department.

Candidature of these candidates is provisional subject to their being found eligible in all respects. The candidates will be required to produce the original certificates in support of their claims pertaining to age, educational qualifications, category and disability, if any, etc. at the time of their Personality Test. They are, therefore, advised to keep the said documents ready with them.

The Personality Test/viva-voce of these candidates shall begin w.e.f. 31.08.2023 and will be held in the Office of the J&K Public Service Commission at Solina, Srinagar. The e-Summon Letter of Personality Test of candidates being called for Interview may be downloaded from the Commission's Website <http://www.jkpsc.nic.in> from 24.08.2023. The candidates who are not able to download e-Summon Letter for Personality Test, should immediately contact at the J&K Public Service Commission office, Jammu/Srinagar. No paper Summon Letters will be issued for the Personality Test/Interview by the Commission. The date and time of Personality Test will not be intimated to the qualified candidates individually.

**No request for change in the date and time of the Personality Test intimated to the candidates will be entertained.**






