- a) A Sportsperson who has represented India In International Games/Competitions namely Olympic Games/ Para-olympic / World Cup (played once in four years)/ Asian Games/Commonwealth Games/International Cricket Matches (Main Indian Team) / World University Games, in any of the sports disciplines mentioned In Annexure-I to S.O. 12 dated 06.01.2022 read with Annexure-IIA to S.O 412 dated 02.08.2023;
- b) A person who has represented India In International Competitions namely World Championship / Asian Championship / Commonwealth Championship/ SAF Games/ Championship in any of the sports disciplines mentioned in Annexure-I to S.O. 12 dated 06.01.2022 read with Annexure-IIA to S.O 412 dated 02.08.2023;

- 1. Only those candidates should apply who fulfill the qualification and eligibility criteria as laid down in the rules notified vide S.O. 12 dated 06.01.2022 read with S.O 412 dated 02.08.2023.
- 2. For the purpose of appointment under the aforementioned Rules, the applicant should have represented at the District, State/UT and National level competitions prior to International competitions.
- 3. Those candidates shall be considered for the quota of Calendar years 2014 to 2022 who have secured position or represented in any event / Game / competitions recognized under these rules as would qualify him/her to be an outstanding sportspersons under these rules during 05 years preceding the relevant year of allotment as specified in detail in the previous advertisement notification issued vide No. YSS-Adm/219/2021-08-YS&S, dated 17.01.2022.
- 4. The Sports disciplines covered under the above rules are Athletics, Badminton, Basketball, Cricket, Football, Hockey, Swimming, Table Tennis, Volleyball, Tennis, Weightlifting, Wrestling (International Style), Boxing, Cycling, Gymnastics, Judo, Shooting, Archery, Equestrian sports, Handball, Rowing, Roller/Ice Skating, Skiing, Squash, Billiard & Snooker, Chess, Golf, Kabaddi, Karate, Kayaking & Canoeing, Polo, Powerlifting (composite events only), Taekwondo, Yachting, Kho-Kho, Softball, Wushu, Fencing, Sports for physically challenged, Baseball, Netball, PencakSilat, Triathlon and Ice Hockey.

 - iii. Respective International Federation; OR
 - iv. Respective Recognized National Federation.
 - v. Incomplete applications or applications with unfilled columns will not be entertained.
 - vi. Only such academic, professional and technical qualification shall be considered, which the applicant is in possession of on the date of receipt of application. Any qualification/experience acquired thereafter shall not be taken into account for any purpose.
 - vii. The sports merit shall be determined as per Annexure-II of S.O. 12 dated 06.01.2022 read with Annexure-IIA to S.O 412 dated 02.08.2023.
- 8. Outstanding Sportspersons not exceeding 25 in number in a calendar year, who could not be considered for appointment in Government service during the period from 2014-2021, would be considered for appointment under these rules against the cumulative direct recruitment quota vacancies accrued @ 25 per calendar year during the period from 2014-2021 against the Non-Gazetted posts [Level 4 (25500-81100)].
- 9. The maximum number of appointments of outstanding sportspersons against the direct recruitment quota in the J&K Sports Cadre for outstanding sportspersons in the Youth Services and Sports Department shall not exceed 05 in Gazetted Cadre and 25 in Non-Gazetted Cadre during the calendar year.
