**Subject: Provisional Select List for the post of Assistant Professor (Tuberculosis and Respiratory Diseases) in various GMCs in Health & Medical Education Department.**

### Notification No. 101-PSC (DR-S) of 2023 Dated: 21.11.2023

Whereas, Health & Medical Education Department, vide letter No. MEGAZ-187/2014 dated 18.08.2021 read with ME-GZtd/317/2021 (e-office), dated 14.03.2022, ME-Gztd/56/2022 (e-office), dated 06.04.2022 and ME-Gztd/21/2022 (e-office), dated 07.07.2022 referred **one (01)** post under open merit category in GMC Doda of **Assistant Professor, Tuberculosis and Respiratory Diseases** to the J&K Public Service Commission, for selection of suitable candidate; *and,*

Whereas, the J&K Public Service Commission, vide Notification 28 -PSC (DR-P) of 2023 dated 08.06.2023, advertised the said posts for selection; *and,*

Whereas, the Health & Medical Education Department, again, vide letter No. Me-GZtd/246/2022 e-Office dated 05.12.2022 and No. ME-Gztd/246/2022-02 (CC: 7037074) dated 26.07.2023, referred **four (04) posts of Assistant Professor, Tuberculosis** one each in GMC Anantnag, Baramulla, Handwara and Udhampur under open category, to the J&K Public Service Commission, for selection of suitable candidates; *and,*

Whereas, the J&K Public Service Commission, vide Notification No. 35-PSC (DR-P) of 2023 dated 03.08.2023, advertised the said posts for selection; *and,*

Whereas, a written test was conducted on 29.10.2023. The result of the written test was declared vide Notification No. PSC/Exam/S/2023/84 dated: 14.11.2023, in pursuance of Rule 42 of J&K Public Service Commission (Conduct of Examination) Rules, 2022 and Rule 31 of J&K Public Service Commission (Business & Procedure) Rules, 2021 as amended upto date; *and,*

Whereas, four (04) candidates qualified for interview for GMC Anantnag, 03 for GMC Baramulla, 01 for Doda, 03 for GMC, Handwara and 03 for GMC Udhampur. Since, some candidates were common, as such, only 05 candidates had to be called for interview; *and,*

Whereas, the viva-voce of candidates was conducted on 17.11.2023, with the assistance of Expert from outside of UT.

Now, therefore, on the basis of the performance in the written test, interview, and other related attributes in pursuance of Rule 44 (ii) of the J&K Public


Service Commission (Business & Procedure) Rules, 2021, the merit of the candidates who appeared in the interview is enclosed as **Annexure A** to this Notification.
