Sub:- Engagement as Stipendiary Senior Residents.

Ref:- Recommendations of Designated Selection Committee held on 30th December 2023

OFFICE ORDER NO: SIMS/ACAD/ 06 OF 2024

DATED: 01. 01. 2024

Pursuant to the recommendations of designated selection committee, sanction is hereby accorded to the engagement of doctors for a period of one year as Stipendiary Senior Residents in the departments shown against each as per the list annexed at ANNEXURE-"A".

The tenure engagement of Senior Residency shall be governed by the following terms and conditions:

1. That Senior Resident shall be entitled to a monthly stipend of Rs.67,700/- plus usual allowances as admissible under rules.
2. That the engagement shall not confer any right on the engagee to claim continuation or extension beyond the mentioned term and shall be deemed to be automatically relieved upon expiry of term.
3. That the engagee shall be entitled to HRA only in case no campus accommodation is allotted and subject to obtaining of certificate to this effect from Estates Officer, SKIMS.
4. That there will be no winter/summer vacation during the tenure engagement.
5. That the tenure engagee shall not undertake any kind of private practice (part/full time) or job anywhere else. He/she shall have to work on full time basis.
6. That he/she shall observe duty timings applicable at the place of posting.
7. That administration has the discretion to change working hours, shift and duty timings as and when required in the interest of administration /patient care.
8. That the first month's salary of the engagee(s) shall be kept as security deposit and shall be released only after completion of first year tenure. If the doctor leaves the tenure prematurely/midway, he/she shall have to pay Rs. 50,000/- as penalty.
9. That in case any engagee desires to leave the job midway he/she has to give two months advance notice, failing which a fine of Rs. 50,000/= has to be deposited by him/her in lieu of notice.
10. That engagee shall be entitled to 14 days casual leave per year and shall also be entitled to 15 days Earned Leave per year during their tenure. They will not be entitled to any other kind of leave during their tenure of Senior Residency at SKIMS. However, the female candidates are entitled to avail a total of 45 days Maternity leave when applicable even when the tenure is extended beyond one year.
11. That engagee(s) shall be required to submit the affidavit duly attested by First Class judicial Magistrate to the effect that:
 - a. *In case adverse report regarding his/her Character and Antecedents is received from CID Head quarter, J&K to whom a reference shall be made by the SKIMS, he/she shall not claim for engagement which shall be deemed to have been cancelled ab-initio;*
 - b. *If verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the engagement of the candidate shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her.*

- c. *The salary of the engagee(s) shall not be drawn and disbursed to him/her (them) unless a satisfactory report in respect of (a) and (b) above are received in his/their favor.*
 - d. *In case he/she desire to leave the job after completion of first six months, he/she has to give two months advance notice, failing which a fine of Rs. 50,000/= has to be deposited by him/her.*
 - e. *He/she will not resort to indiscipline or be a part of any protest or strike within the SKIMS Campus. In case, he/she does so, he/she shall be deemed to have committed a gross misconduct and shall be relieved/disengaged from the assignment from the date of resorting to such strike or protest without any prior notice. Non-compliance of terms and conditions shall otherwise make him/her liable for action as warranted under rules/law.*
 - f. *He/she shall accept all terms & conditions of tenure engagement and shall abide by all the rules governing the tenure engagement and any breach thereof shall make him/her liable to be relieved from the tenure job immediately.*
12. *The engagee(s) are required to complete all the requisite formalities and are directed to report in Academic Section SKIMS on 06-01-2024 at 11.00 A.M for screening/verification of documents/certificates. Further, they have to join their assignment within 21 days from the date of issuance of this order. The candidate(s) who fails to join within a period of 21 days from the date of issuance of the engagement order shall forego his/her right to engagement which shall be deemed to have been cancelled ab-initio without any further notice.*

Note:-

The candidate(s) who fails to provide requisite Certificates/documents at the time of screening shall also forego his/her right to engagement and shall be deemed to have been cancelled ab-initio without any further notice. PSC confirm doctors should get himself/herself relieved from his/her parent department before joining the assignment.
