## **ONLINE SELECTION PROCEDURE:**

- 1. Application forms for this position can be filled in online in Google Forms. The Google Form link is available on the CSIR-IIIM website (<a href="www.iiim.res.in">www.iiim.res.in</a>). The filled-in Google Form should be submitted by or before 10<sup>th</sup> July 2024 up to 5:00 PM.
- 2 Application Forms after the scheduled date and time, i.e., 10<sup>th</sup> July 2024, up to 5:00 PM, will not be entertained for application.
- Only eligible candidates shall be accessed for the viva voce on the date of the interview. The list of eligible candidates and the date for the interview will be displayed on the CSIR-IIIM Website, <a href="www.iiim.res.in">www.iiim.res.in</a>, by the evening of 12<sup>th</sup> July 2024.
- 4 Eligible/shortlisted candidates should send the scanned copies of requisite documents (as mentioned in the Google Form) by 5:00 pm of 17<sup>th</sup> of July 2024 and shall attend the online interview through Video Conferencing on M.S. Teams (Link will be shared before interview).
- 5 In case a large number of candidates apply, the Screening Committee may re-visit the screening criteria and shortlist the candidates for interview in proportion to the available vacancy/ vacancies.
- 6 Candidate has the option to interact in English/Hindi before the Selection Committee.
- 7 The position is purely temporary on a contract basis and co-terminus with the project.
- 8 In case the final certificates reflect CGPA/SGPA/OGPA Grades, the candidate should convert the same into an equivalent percentage as per the approved formula of the University in the Google Form.

9 To avoid any inconvenience, only those candidates who strictly fulfill the eligibility criteria and possess the degrees/mark sheets in the subjects as per essential qualification mentioned above should apply for the interview.
