
1. Whereas, the J&K Public Service Commission conducted the **Written Test for filling up of post(s) of Lecturer-I Civil Engineering, Lecturer-I Electrical Engineering, Lecturer-I Computer Engineering, Lecturer-II (Non-Engg.) Wood Technology, Lecturer-II (Non-Engg.) Food Technology, Lecturer-II (Non-Engg.) Garment Technology, Lecturer-I Architect Assistantship, Lecturer-II (Non-Engg.) Medical Lab Technology, Lecturer-II (Non-Engg.) Office Management & Computer Application, and Lecturer-II (Non-Engg.) Textile Designing in Department of Skill Development, on 15.09.2024 and 17.09.2024; and**
2. Whereas, the Provisional official answer key(s) were notified and uploaded on the official website of the Commission for information of the candidates on 15.09.2024 & 17.09.2024, inter-alia notifying that, if any candidate feels that the keys to any of the questions is wrong/incorrect, he/she may prefer a representation/objection on the prescribed proforma to the Controller of Examinations within a period of three days from the date of its notification along with documentary proof /evidence and the fee of Rs.500/- per question; and
3. Whereas, in response to the said notifications, number of objections/representations were received by the J&K Public Service Commission against Provisional Answer Keys issued in respect of 04 disciplines viz. **Civil Engineering, Electrical Engineering, Computer Engineering, Medical Lab Technology**. However, no objections have been received in respect of 06 disciplines viz. Wood Technology, Food Technology, Garment Technology, Architect Assistantship, Office Management & Computer Application and Textile Designing; and
4. Whereas, all the objections/representations were referred to the Committee(s) of Experts as envisaged in Rule 10 (d) of the J&K Public Service Commission


(Conduct of Examination) Rules, 2022, as amended from time to time, for Independent Expert opinion; and

5. Whereas, the independent team of Experts have recommended changes in the Provisional Official Key(s) in respect of the said papers;

Now, therefore, in view of the above and on the basis of opinion of the independent teams of Experts, it is hereby notified that:-

- a) The changes recommended by the Committee(s) of Experts are hereby adopted and the Final Official Answer Key(s) are annexed to this notification as Annexure A, B, C, D, E, F, G, H, I and J in respect of 10 disciplines viz. Civil Engineering, Electrical Engineering, Computer Engineering, Wood Technology, Food Technology, Garment Technology, Architect Assistantship, Medical Lab Technology, Office Management & Computer Application and Textile Designing respectively. In terms of Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022 as amended upto date, the marks allocated to the deleted questions **shall be individually added to the marks secured by the individual candidates to ensure that the mark(s) allocated for the question paper as a whole remain unchanged**, at the time of calculation/compilation of award sheet before the declaration of the result;
- b) The amount deposited @ Rs 500/- per question is also hereby released in respect of genuine/correct representations and same shall be transferred through RTGS in individual account of candidates.
