
As per the Indent, the qualification prescribed for the posts was (is) as under:

***"Graduation from any recognized University with 35 words type speed on computer key board per minute".***

The J&K Services Selection Board, conducted the type test for these posts for which the result was declared on 08.08.2024, and accordingly, the Written Examination (OMR based) of the successful candidates for these posts of Junior Assistant was conducted on 25.08.2024. Based on the performance of the candidates in it, the Board, vide Notification No. JKSSB-COE0EXAM(UT)/32/2024-03(7551754) dated 18.09.2024, published the Result/Score-sheet of the candidates.

After the publication of Result/Score-sheet, the candidates, falling under the consideration zone, were called for Document Verification vide Notification No. JKSSB-COE0EXAM(UT)/32/2024-03 (7551754) dated 18.11.2024, at both Jammu & Srinagar office w.e.f 10.12.2024 to 17.12.2024, followed by supplementary DV w.e.f 07.01.2025 to 09.01.2025.

The Final Selection List for these posts of Junior Assistant, as prepared by the concerned Selection Committee, was approved by the Board in its 302<sup>nd</sup> Board Meeting held on





08.04.2025, and subsequently notified vide Notification No. 06-Selection of 2025 dated 21.04.2025, under endorsement No. JKSSB-Scry/2/2025-06 (E-7628025) dated 21.04.2025.

Accordingly, the undersigned is directed to forward herewith the selection list of **02 posts** of "Junior Assistant" Civil Aviation Department, UT Cadre, advertised vide Notification No. 04 of 2022 dated 27.07.2022 under Item No. 124 as per "**Annexure-A**" to this communication.

The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree certificates and ascertaining genuineness/validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing Authority.

The Selection of the candidates has been made on the basis of Self-declaration/ Certificates submitted by them and if at any stage, it comes to the notice that any candidate (s) has submitted false information or has secured selection on the basis of fake or invalid document/ Certificates, the selection shall be liable to cancellation at any stage and appropriate Criminal proceedings against such candidate/s may kindly be initiated.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, the candidates whose recommendation are released by the Selection Agency shall submit their Personal Verification Rolls (PVR) before the appointing authority within a period of **21 days** from its release, failing which the candidate(s) shall forego their right to appointment forthwith.
