After successful conduct of Written Examination on 10.03.2024; and subsequent Document Verification, the Final Selection List for these posts of Sub Inspector of Finance Department, was notified vide Notification No. 25- Selection of 2024 dated 29.07.2024; and subsequently vide letter No. JKSSB- Scry/12/2024-06 (E-7479108) dated **29.07.2024**, the same were forwarded to Indenting Department.

The wait list in the instant selection was not forwarded along with the select list, as regulation 68 of the Jammu and Kashmir Services Selection Board (Business and Procedure) Regulations, 2022, provides that for such selections, the wait list shall be forwarded on the request of the Indenting Department.

The J&K Services Selection Board vide letter No. FD- ESTB/13/2024-03-FD (C.No 7595581) Dated 11.02.2025, has received a requisition from Finance department for operation of waiting list against the non-joining of 13 candidates under the respective items 118, 121 & 123, for the post of Sub Inspector, advertised vide Notification No. 04 of 2020 dated 16.12.2020 Division/ District Cadres.

Whereas, the Board as per the decision taken in 290th Board Meeting cancelled the candidature of two (02) candidates, vide Notification No. JKSSB-



Scry/12/2024-06 (E-7479108) dated 20.12.2024, whose recommendations where kept withheld in the Final Selection List on account of various deficiencies.

Therefore, as per the requisition provided by the Indenting Department, the total number of vacancies available for preparation of waiting list is (13 + 2)Fifteen (15) including the vacancies caused by cancellation of candidature of two candidates.

Whereas, the Selection Committee re-constituted for these posts, having regard to the candidature, merit/ preference of the candidates, prepared waiting list in respect of eligible candidates in the respective category/ cadre (shown in Annexure "A" to this notification), which was subsequently placed and approved in the 304th Board Meeting held on 15.05.2025.

The Selection of the candidates has been made on the basis of self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection in the list on the basis of false documents/certificates, the selection shall be liable to cancellation at any stage.
