Subject: Cancellation of candidature and Debarment of candidate on account of resorting to unfair means - regarding.

Order No: 341-SSB of 2025

Dated: 31 -10-2025

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) conducted OMR Based Written Examination for the post of J.E (Electrical), Power Development Department, advertised vide Notification No. 02 of 2025 Dated 27.02.2025 on **25.10.2025**; and

Whereas, a candidate namely Mr. Mohammad Zeeshan Dar, S/o Mohd Hussain Dar R/o 58, New Colony Zadibal Srinagar, appeared in the said examination under Roll No. 2070268 at Srinagar Women's College Zakura, Near Batapora Petrol Pump Srinagar (K07);

Whereas, the said candidate has been found in possession/use of mobile phone during the conduct of examination at Srinagar Women's College Zakura, Near Batapora Petrol Pump Srinagar, (K07), as per the report of the Centre Superintendent and Centre observer;

Whereas, notwithstanding the above, vide No. JKSSB-COE0Exam(UT)/101/2023-03(7363646) Dated 27.10.2025, a show cause notice was issued to the said candidate to explain his position. The reply to the said show cause notice was submitted by the candidate and was examined in the light of relevant Rules/Regulations; and

Whereas, the said candidate has admitted that he was in possession of the mobile phone during the conduct of Examination on the prescribed format (Annexure IX) and accepted that it was an offence for which he is liable for disciplinary proceedings relevant Rules/Regulations; and

Whereas, the case was placed before the Unfair Means Committee constituted in terms of Jammu and Kashmir Services Selection Board (Conduct of Examinations) Regulations, 2022 under part XXX (67), and the committee, after considering the nature of the offence and evidence brought on record as well as the reply of the show cause notice submitted by the candidate, recommended as under:-

"The committee observed that the candidate Mr. Mohammad Zeeshan Dar, S/o Mohd Hussain Dar R/o 58, New Colony Zadibal Srinagar, Roll No. 2070268 has committed offence under section 64(b) of Jammu and Kashmir Services Selection Board (Conduct of Examinations) Regulations, 2022.

Therefore, the committee recommends cancellation of the candidature of the candidate for the post of Junior Engineer (Electrical), besides debarment for a period of five (05) years for all examinations and selections conducted by JKSSB with effect from the date of incident i.e. 25.10.2025. The seized Mobile phone can be handed over to the said

candidate after expiry of six months from the date of incident on his personal request."

Whereas, the recommendations of the Unfair Means Committee were placed before the Board in its 325th Meeting held on 31-10-2025, which accepted the recommendations of the Unfair Means Committee with some modification and decided as under: -

- 1. To cancel the candidature of the candidate Mr. Mohammad Zeeshan Dar S/o Mohd Hussain Dar R/o 58, New Colony Zadibal Srinagar, Roll No. 2070268, for the post of J.E (Electrical) advertised vide notification 02 of 2025 Dated 27.02.2025.***
- 2. To debar the said candidate for a period of three (03) years from all examinations and selections conducted by JKSSB with effect from the date of incident i.e. 25-10-2025.***
- 3. To handover the mobile phone seized from the candidate during the conduct of examination, after six months from the date of incident (25.10.2025) on his personal request to the Controller of Examinations/Secretary.***

Therefore, in view of the above and as per section 69 of Jammu and Kashmir Services Selection Board (Conduct of Examinations) Regulations, 2022, the candidature of candidate Mr. Mohammad Zeeshan Dar, S/o Mohd Hussain Dar R/o 58, New Colony Zadibal Srinagar, for the post of JE (Electrical) advertised vide notification No. 02 of 2025 dated 27.02.2025 is hereby cancelled. The candidate is further debarred from appearing in all the examinations and selections conducted by the Board (JKSSB) for a period of three (03) years from the date of incident/examination i.e. 25.10.2025. The seized mobile phone shall be handed over to the said candidate after six months from the date of examination on his personal request to Secretary/Controller of Examinations.
