Whereas, the Jammu and Kashmir Services Selection Board, vide Indent Nos. LD(Estt) 2019/51 dated 05.10.2020, followed by No. LD(SL) 2015/14-Adv.Gen dated 08.12.2020 and No. LD(SL) 2015/14-Adv.Gen dated 17.04.2021, received **32 Posts of Legal Assistant & Junior Legal Assistant** from Department of Law, Justice and Parliamentary Affairs, which were put to advertisement vide Notification Nos. 05 of 2020 dated 24-12-2020 and 03 of 2021 dated 04-06-2021, as per the following category-wise break up:

Whereas, the requisite qualification for selection against these posts, as per the Indent/ advertisement, was mentioned as under:

Legal Assistant	A Bachelors Degree in Law of a University established by Law in India having two years actual practice at Bar.
Junior Legal Assistant	A Bachelors Degree in Law of a University established by Law in India.

Whereas, the Department of Law, Justice & Parliamentary Affairs, vide letter No. Law-Estt/69/2021-10 dated 02.08.2021, communicated a following revised breakup for the post of Junior Legal Assistant advertised vide Notification No. 03 of 2021, Item No. 599:

Accordingly, the J&K Services Selection Board (JKSSB) vide Notification No. SSB/Secy/2021/7275-93 dated 25.10.2021, revised the breakup of posts for Item No. 599, reflecting the revised details as under:

Whereas, an OMR-based written examination for these posts was conducted on 20.03.2022. Subsequently, based on performance in the written test, the Result/Scoresheet of the candidates was notified vide No. JKSSB-COEEXAM(UT)/42/2023-03 (7189468) dated 03.01.2025.

Whereas, the JKSSB, vide Letter No. JKSSB-PLAN/19/2023-03 (E-7209231) dated 20.11.2023, returned the **two posts (02)** one each under OM and SC categories of Item No. 599 (03 of 2021) to the Department Law, Justice & Parliamentary Affairs as requested by the department vide Letter No. LAW-Estt/134/2021-10 dated 11.10.2023

Whereas, after the above revisions, the final breakup for the post of Junior Legal Assistant advertised under Notification No. 03 of 2021, Item No. 599, stands as follows.

Whereas, a Document Verification notice was issued vide JKSSB-COE0EXAM(UT)/42/2023-03 (7189468) on 13.02.2025, whereby candidates falling in the consideration zone were called for verification of their original documents on 25.02.2025. For the candidates who failed to attend on the said date, a supplementary document verification was held on 10.03.2025. Pursuant to O.A. 373/2025, a document verification was held on 05-06-2025.

Whereas, a Selection Committee was constituted for preparing the Selection List for the remaining **30 posts** who prepared the Provisional Selection List for **30 posts** in accordance with the Merit/ Eligibility and preference of the candidates as per the extant rules and same was notified vide No. JKSSB-Scry/7/2025-03 (E-7680969) dated 27.06.2025, by reserving two posts one under SC for Item No. 153 and one under ALC for Item No. 150, seeking objections/ grievances from the candidates through the email address legaljrlegalsstt2025@gmail.com within period of 15 days from the date of issuance of its notification; and

Whereas, pursuant to the above, various representations were received from the candidates, pertaining broadly to submission of documents w.r.t. withheld cases, correction in particulars etc., which were examined and those based on merit, have been taken into consideration and necessary changes, where-ever required, have been made as per the available record/ extant guidelines while finalising the selection; and

Whereas, an Additional Document Verification was conducted on 04.07.2025 as per 306th Board decision, wherein 07 candidates were shortlisted, for the post of Legal


Assistant under Item No. 150, which was kept reserved in Provisional Selection List, to fill up the vacant post earmarked for the ALC/IB category; and

Whereas, the Selection Committee prepared the Final Selection for these **30 posts** in accordance with the merit/eligibility of the candidates and as per the rules in vogue and placed the proposal for notifying the Final Selection List, for these **30 posts** of Legal Assistant & Junior Legal Assistant, belonging to Department of Law, Justice & Parliamentary Affairs, advertised vide Notification No's. 05 of 2020 dated 24-12-2020 and 03 of 2021 dated 04-06-2021, in 333rd Board Meeting held on 29.12.2025, which after due deliberation on various aspects related to the instant selection, approved its notification by keeping one post reserve under SC Category of Item No. 153 (subject to the outcome of pending litigation).

Now, therefore, the Final Selection List of the candidates for **30 posts** of Legal Assistant & Junior Legal Assistant, belonging to Department of Law, Justice & Parliamentary Affairs, advertised vide. Notification No's. 05 of 2020 dated 24-12-2020 and 03 of 2021 dated 04-06-2021, is hereby notified as per "**Annexure A**" to this Notification. It is further notified that:

- i. The Final Selection List shall be subject to outcome of the OAs /Writ Petition(s), if any, pending in the competent court of law.
- ii. The List shall also be subject to the *outcome of any pending inquiry*, involving any candidate(s), as figuring in this list.
- iii. The formal recommendation of the concerned indenting department shall be forwarded separately.
- iv. The Selection of the candidates has been made on the basis of Self-declaration/ certificates submitted by them and if at any stage, it comes to light that they have submitted false information or have secured selection on the basis of fake or invalid documents/ certificates, the selection shall be liable to cancellation at any stage.
- v. This being a combined selection, the Waiting List shall be notified and forwarded on the request of the Indenting Department, against the non-joining candidates, if any.
