Ten (10) year's experience in the relevant subject out of which at least eight years should be as Scientist/Teacher or equivalent position in the pay band-III of ₹15600-39100 + GP of ₹5400/6000/7000/8000 (pre-revised) and two year as Associate Professor/Sr. Scientist or equivalent in the pay band-IV of ₹37400-67000 with grade pay of ₹8700/9000.
- iii. Good research experience as evidenced by publications.

Desirable

 - ii) Ph.D. degree (with course work) in concerned subject as prescribed by the UGC Regulations, 2009 (Ph.D. is relaxed for candidates having post-graduation degree in Vety. Sciences provided the candidate has one publication in NAAS rated referred Journal and NET as Essential Qualification); and
 - iii) NET or at least two full length publications having a NAAS rating not less than 4, on the last date of submission of application

- i) Master's degree with 55% marks or equivalent grade in OGPA or equivalent postgraduate qualification in the concerned subject; and

 - b) Evaluation of Ph.D thesis is done by at least two external examiners.
 - c) Open Ph.D. viva voce of the candidate had been conducted.
 - d) Candidate has published two research papers from his/her Ph.D. work out of which at least one must be in referred Journal.
