- Applications are invited from eligible candidates for Vacant Positions shown in the Annexure to this Notification. The advertised positions are Scheme positions and temporary and not in a pay scale.
- 2. Eligibility:-

To be eligible the candidate must be:

- Permanent Resident of J&K State.
- ii. Possess Academic/professional/technical qualifications and other eligibility conditions as required and specified against each position/item in the **Annexure** by or before the last date of submission of application forms i.e 27.11.2018.



- iii. The candidates be within the Age limit as prescribed by the Government. However, the Age limit shall be determinable with reference to **01.01.2018**.
- iv. The candidates must send in enclosed format the applications along with Xerox copies of required certificates (self-attested) at the address of Mission Directorate ,ICPS (Rehmat Avenue ,Sanat Nagar,Baghat Srinagar 190005) or Mission Directorate ,ICPS (Hajj House, Rail Head Complex ,Jammu) along with Demand Draft for ₹300 in favor of Mission Director, ICPS by the stipulated date. The candidates, who have already deposited the fee, need only to append the copy of the receipt with the application form.
- 2. The last date for the submission of applications for advertised positions above shall be the cut off date for determining the eligibility to apply for the position. Any qualification/ experience acquired after last date of receipt of application form i.e. 27 .11.2018 shall not be entertained.
- 3. In case of huge response, the candidates may be shortlisted for interview/ Viva-voce on the basis of marks obtained in the eligibility qualification.
- 4. Call letters shall not be issued individually; however, wide publicity shall be given through print and electronic media, official Website (www.jkicps.org) of the ICPS about the venues, dates of the interview/Viva-voce for the information of eligible /shortlisted candidates. Plea of being unaware of the dates/ schedule for interview shall not be entertained.
