Whereas, the qualification prescribed for the said post of Junior Anesthesia Assistant, as per the indent received from the concerned Indenting Department, was:

Whereas, the written examination for the said post was held from 14th to 18th of November, 2018 and after the declaration of result a provisional selection list was prepared and issued by the Board vide Notification No. SSB/Sel/Secy/2017/13864-67, Dated: 30 12 2017; and

Whereas, subsequently for finalization of selection list for the aforementioned post, 33 candidates were called for document verification/counselling on 29th of January, 2018 by the Jammu and Kashmir Services Selection Board; and

Whereas, the above said selection process for the post of "Junior Anesthesia Assistant" was challenged before the Hon'ble High Court of Jammu and Kashmir by way of SWP's bearing Nos. 2047/2018, 2308/2018 and 2917/2018 and the Hon'ble High Court vide its order dated 03.06.2019 was pleased to dismiss SWP No. 2047/2018 and SWP No.2917/2018 (Clubbed petitions) and dispose of SWP No. 2308/2018 with the direction to the Board to proceed ahead with selection process in accordance with the communication dated 03.08.2018.

Whereas, the aforesaid Order dated 03.06.2019 passed by the Hon'ble Court was challenged before the Hon'ble Division Bench of the Jammu and Kashmir High Court in separate LPAs bearing Nos.185/2019 and 171/2019; and

Whereas, the Hon'ble Division Bench of the High Court of Jammu and Kashmir vide order dated 13.09.2021 was pleased to dispose of LPA No.185/2019 C/W LPA No.171/2019, by upholding judgment and order passed by the Single Judge and thereby dismissed both the said appeals; and

Whereas, a similar case on the subject titled "Mansoor Ahmad Sheikh & another V/S State & others was also filed before the Hon'ble High Court and the same was transferred to Hon'ble Central Administrative Tribunal (CAT) where it came to be registered as TA No. 6409/2020. The said TA also stands dismissed as withdrawn vide Order dated 01.10.2021 passed by the Hon'ble Central Administrative Tribunal (CAT); and

Whereas, the selection list alongwith requisite waiting list for the aforesaid posts of Junior Anesthesia Assistant was considered and approved by the board in its 154th Meeting held on 26.06.2019; and



Whereas, in deference to the aforementioned orders passed by the Hon'ble High Court and the Hon'ble Central Administrative Tribunal (CAT) together with the above referred to decision of the board and other relevant facts and circumstances of the case, it was decided to notify the selection list alongwith waiting list for the post of "Junior Anesthesia Assistant" (Health & Medical Education Department) District Cadre Budgam, Pulwama, Kupwara, Ganderbal and Baramulla under Item Nos.671, 693, 685, 674 and 668 respectively pursuant to notification No. (07 of 2015).
