Sub:- Appointment of candidates as Depot Assistant in Food, Civil Supplies & Consumer Affairs Department Kashmir under Hon'ble Prime Minister's Special Package for Kashmiri Migrants and Non-Migrants Kashmiri Pandits - operation of waiting list thereof.

NOTIFICATION

Whereas, the Administrative Department, FCS&CA Civil Secretariat J&K Jammu vide letter No. FCS&CA/Estt/69/2019 dated 15.10.2021 forwarded select list of candidates (received from Department of Disaster Management, Relief, Rehabilitation and Reconstruction, Civil Secretariat, Jammu vide No. DMRRR-MR/154/2021 dated 14.10.2021 / J&K Service Selection Board vide No. SSB/Secy/Se1/2021/7046-53 dated 14.10.2021) for three hundred (300) posts of Depot Assistants carrying substantive pay level of Rs. 14800-47100 (SL-1), in Food, Civil Supplies & Consumer Affairs Department, District Cadre Kashmir;

Whereas, this office vide notification issued under endorsement No. DFCS&CAK/Adm/B-X-25/EC3 dated 15.10.2021 informed all the concerned candidates to submit their verification rolls in triplicate in the offices of Directorate of Food, Civil Supplies & Consumer Affairs Kashmir / Jammu for verification of their character and antecedents which also got published in local dailies of Jammu and Kashmir viz The Daily Aftab Srinagar on 16.10.2021, Kashmir Images on 16.10.2021 and Daily Excelsior Jammu on 16.10.2021;

Whereas, after receipt of provisional /final security clearance from Criminal Investigation Department J&K, formal appointment orders in respect of said candidates stands already issued;

Whereas, in view of non-joining of appointed candidates within the stipulated time period of twenty-one (21) days and non submission of verification rolls by other candidates in the offices of Directorate of Food, Civil Supplies & Consumer Affairs Kashmir / Jammu, this office vide notification issued under endorsement No. DFCS&CAK/Adm/B-X-25/PMP dated 17.03.2022 notified candidates in the waiting list and were directed to submit their verification rolls in triplicate in the offices of Directorate of Food, Civil Supplies & Consumer Affairs Kashmir / Jammu for verification of their character and antecedents within a period of fifteen (15) days from the date of publication of this notice in leading newspapers of Jammu and Kashmir;

Whereas, the candidates of the waiting list as detailed in the annexure "A" to this notification have failed to submit their verification rolls till date in response to this office notification dated 17.03.2022 duly published in local dailies of Jammu and Kashmir, viz Srinagar Times on 19.03.2022 & Kashmir Images on 20.03.2022.

Whereas, one candidate have submitted his verification roll lately and his pointment is under process.

Whereas, it appears that they are not interested to join this department;

Now, therefore, in view of above, the candidates falling next in the waiting list as detailed in the annexure "B" to this office notification are advised to submit their verification rolls in triplicate in the offices of Directorate of Food, Civil Supplies & Consumer Affairs Kashmir / Jammu for verification of their character and antecedents within a period of fifteen (15) days from the date of publication of this notice in leading newspapers of Jammu and Kashmir.
