Subject: Statistical Assistant Course Departmental Examination, 2022 - rejection of candidature thereof.

NOTICE DATED: 28.12.2022

Whereas, vide Notification No.PSC/Exam/30/2022 dated 20.09.2022 application forms for appearing in Junior Statistical Assistant Course/Statistical Assistant Course/Statistical Officer Course Departmental Examination, 2022 were invited under three courses viz. Old syllabus (SRO 476), New syllabus (31-PD of 2000) and Revised syllabus (SO 312). Accordingly, candidates are required to apply against the relevant course; and

Whereas, in response to said notification 178 applications were received in Statistical Assistant Course Departmental Examination. Out of 178 applications, 16 candidates had applied against Old syllabus, 14 candidates had applied against New syllabus and 148 candidates had applied against revised syllabus; and

Whereas, on scrutiny of the record, it has been found that 18 candidates who are otherwise eligible under old syllabus, have applied under revised syllabus. Vide communication No.DES/PS/E-Form/Eligibility/2022/6637 dated 13.12.2022, the Director General, Directorate of Economics and Statistics, J&K has also forwarded the Eligibility Certificate in respect of the said candidates under old syllabus.

Now, in this backdrop, the candidature of the following candidates is hereby rejected on account of non-submission of the requisite documents: -
